Clinical Initatives



DIABETES

Nearly one in four American adults is living with diabetes. It is the leading cause of blindness, kidney failure, and lower limb amputation in the United States.

Since spring of 2015, teams from each Owner system have been meeting regularly to share best practices and hold each other accountable for their implementation.

As a result, over 53,000 people with diabetes under our care are now optimally controlled. This incremental improvement has not only prevented heart attacks and strokes, but has also avoided over \$38 million of medical costs.

Advance Care Planning

Most patients with serious illness report they would prefer to die at home. Yet, most die in the hospital.

Advance care planning allows patients to determine and communicate the care they want during all phases of their healthcare, and most importantly before critical decisions must be made. Having this in writing can also provide direction for the family and care team when patients are no longer able to make their own decisions.

Through our combined efforts more than 160,000 older adults have advance care documents in place.







TOTAL KNEE REPLACEMENT

Over the next 12 years, the demand for total knee replacement is projected to increase by a staggering **673%**.*

Since bringing over 70 orthopedic surgeons, nurses, physical therapists, quality and operational experts together to discuss and agree upon best practices, *our six Owner systems have reduced post-operative complications by 49% and length of hospital stay by 39%, which is amongst the best in the country.*

<u>ELECTIVE LOW BACK SURGERY</u>

Four out of five Americans suffer from low back pain at some point in their lives, and about 500,000 people have back surgery every year. Our Owners have been working since fall of 2016 to improve the outcomes for these patients. *Collectively we have reduced the complications following back surgery by an impressive 67%!*

CORONARY HEART DISEASE

Heart disease is the leading cause of death in the United States in both men and women, accounting for **25%** of all deaths.

By focusing on more rapid intervention for heart attacks, strategies to shorten ICU stays following surgery, and increasing the usage of cardiac rehabilitation, we have reduced the death rate following heart surgery by a remarkable 59%.



OPIOID USE/MISUSE

Opioid misuse is the major public health crisis of our age.

In 2014 there were 18,893 overdose deaths in the United States related to prescription pain relievers, and 10,574 overdose deaths related to heroin.

Since gathering experts from all six Owner systems to reduce opioid addiction and opioid deaths in the state of Wisconsin, we have reduced the number of opioid prescriptions written by more than 200,000!







SURGICAL SITE INFECTIONS

According to the World Health Organization, in the United States, surgical site infections contribute to patients spending more than **400,000 extra days in hospital** at a cost of an additional \$10 billion per year.

To minimize this risk, operating room staff from all six Owners have worked together to implement the Center for Disease Control (CDC) guidelines and safeguards. *As a result, we have seen a 36% drop in colon surgery infections.*



COMPLEX CARE MANAGEMENT

More than one in ten adults in the United States have five or more chronic health conditions. Taking proper care of all of these can be challenging.

All six AboutHealth Owner systems now have complex care managers who come alongside to provide personalized assistance and guidance.

Patients who partner with these professionals experience fewer hospitalizations and emergency room visits resulting in better quality of life and reduced health care costs.



Clinical Initiatives



BEHAVIORAL HEALTH INTEGRATION

An estimated 25-35% of people with chronic diseases suffer from behavioral conditions such as depression.

There is a national shortage of behavioral health providers, in fact the current mental health providers in Wisconsin can meet only 25% of the need.

To solve this, the Owners of AboutHealth have incorporated behavioral health professionals into our primary care teams. We are also beginning to share staff and other resources to better match capacity with demand. Additionally, we are recruiting collectively rather than competitively and leveraging telepsychiatry to reach the more remote parts of the state. These efforts have improved access and significantly reduced behavioral health appointment wait times.

POST-ACUTE CARE

Nearly eight million hospital stays, **22.3% of all hospitalizations**, result in a discharge to a post-acute care facility such as a skilled nursing home. Medicare spending on post-acute care is increasing faster than the growth of all other Medicare spending categories.

Our Owner systems partner with high performing home health agencies, skilled nursing facilities, and inpatient rehabilitation facilities to ensure that all patients are receiving the proper level of care following hospital discharge.







ANTIMICROBIAL STEWARDSHIP

Antimicrobials used inappropriately will result in unnecessary exposure to medications, persistent or progressive infection, emergence of resistant organisms, and increased costs. In the United States, antibiotic resistance causes **23,000+ deaths per year and >2.0 million illnesses.** It is estimated that **30-50%** of all antibiotics prescribed in the hospital are **unnecessary.**

To address this, AboutHealth convened clinicians and staff from hospitals and clinics to share best practices and agree upon when, and when not to prescribe antibiotics.



Population Health

Collectively as AboutHealth, our six Owners share best practices to improve the health of our populations, our patients' experience, and the well-being of our care teams, while also reducing the cost of care. We use our combined experience to capitalize on those interventions proven to be effective. We are committed to being completely transparent and fully accountable.

Analytics

Since the advent of the electronic health record, healthcare has had access to a significant breadth and depth of rich data, but relative to industries such as manufacturing and finance, has remained information poor. In 2018, AboutHealth embarked on an analytics initiative to assemble and convert clinical and claims data into actionable information. Working in partnership with our Owners, AboutHealth then uses this comparative information in pursuit of our mission to improve clinical outcomes and reduce the cost of care.

Integral Components of AboutHealth's Analytics Include:

Medical expense management dashboards shed light on the drivers of cost and utilization Drill down at the patient level will help to identify gaps in care and enable patient outreach Direct data submission streamlines the reporting process and improves measure quality Patient level detailed records will provide insights into drivers and contributors to clinical quality opportunities

The collection and integration of data from our Owners' electronic health records and our payer partners is no small task. Tremendous progress was achieved in 2018 with full implementation of the first two Owner systems with a third soon to follow. The availability of this comparative data has already begun to yield significant benefits. In addition to timely sourcing of quality and outcome measures for those systems that are live, work has also begun in other areas including utilization of emergency and urgent care services, pharmacy spending trends, and accessibility of behavioral health services. These comparisons have led to actionable discussions between our Owners and advanced our identification of interventions for meaningful change.

Implementation of the remaining AboutHealth Owners will continue into 2020. As each system goes live on the analytics platform, their data will become another point in the comparative analysis of key measures and outcomes. Additionally, value-added capabilities such as social determinants, risk and impactability scoring, utilization reporting, and in/out of network reporting present new information to our Owners to supplement their existing analytics environments.

Shared Services

AboutHealth Owners derive value in aggregating volume and spend to achieve larger scale and buying power. This benefit of scale is supplemental to each Owner's participation in a Group Purchasing Organization. Procuring capital, supplies, and services at reduced costs contributes to our Owners delivering top quality care at a more affordable cost.

The Shared Services committee is responsible for decreasing costs for AboutHealth as a whole and within individual Owner systems. This committee seeks to create savings opportunities for shared services to ultimately reduce the personal and community cost of healthcare.

AboutHealth serves in a centralized role to facilitate vendor negotiations while carefully balancing existing relationships, affiliations, and contracts. Key success factors are our ongoing ability to save Owners consideable money and Owner systems bringing forward common needs that can be negotiated collectively.

Highlights

2018 HCF Savings Generated - \$2,771,937

The demand for affordable access to a high-quality network for small or rural providers continues to grow and securing access at the bandwidth required to support electronic health records is not always available or affordable. The HealthCare Connect Fund (HCF) provides support for high-capacity broadband connectivity to eligible healthcare providers who receive a discount from the fund on all eligible telecommunication expenses.

AboutHealth formed a Healthcare Connect Fund consortium, enabling Owners to request reimbursement from the Fund. Realized savings support Owner system goals, such as reducing communication costs, upgrading to more advanced solutions, or installing new and improved technology.



Shared Services Auditing Service Initiative

Accounts Payable Cost Recovery

In 2018, several of the AboutHealth Owners engaged in a joint effort to assist in the identification and recovery of invoice payment errors and identification of process improvements to eliminate future errors. Utilizing a single recovery/audit service vendor for all their audit recovery efforts, resulted in lower engagement fees than each Owner would have paid individually for the same service.

The analysis/audit performed by the vendor within each Owner organization included:

- Interviews with staff in the purchasing and accounts payable departments.
- Review of the related procedures used in purchasing and accounts payable.
- Review of the paid vendor invoices as well as procurement and accounts payable data files, validating purchases and other related documentation for accuracy in:
 - ✓ Pricing
 - ✓ Contract compliance
 - ✓ Discount terms
 - ✓ Sales tax
 - ✓ Freight
 - ✓ Rebates
 - Erroneous/Duplicate payments to vendors



• Analysis of the payment procedures and processes for supply and service invoices to determine the effectiveness and reliability of those procedures in receiving proper payment.



Total Accounts Payable Audit Recovery = \$615,996

The auditors reviewed all invoices for every vendor within the time period each Owner system requested. This review identified prompt payment discounts offered by vendors and not taken, duplicate payments made for the same invoice, and taxes or freight charged and paid that should have been exempt.

Potential payment error details were reviewed with each Owner to confirm their validity and obtain approval for the auditors to proceed with collection from the vendors. Once approved, the vendors were contacted to remit a check or credit memo for the payment error.

At the conclusion of the audit, a summary of results and a formal audit report were provided. The final report outlined areas of improvement identified, as well as specific recommendations to prevent these issues from occurring in the future.
